To either of the Constables of the Town of Montague in the County of Franklin:

GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the Town of Montague qualified to vote in Town affairs to meet in the Turners Falls High School Theater on Saturday, May 3, 2014 at 8:30 A.M. and to act on the following articles and any motions which may be presented.

ARTICLE 1. To see if the Town will vote to raise and appropriate, transfer from available funds, borrow or otherwise provide the sum of \$10,000, or any other amount, for the purpose of increasing the Henry Waidlich Conservation Fund, or to pass any vote or votes in relation thereto.

ARTICLE 2. To see if the Town will vote to raise and appropriate, transfer from available funds or otherwise provide the sum of \$81,679 or any other amount for the purpose of providing the Town's share of the cost of upgrading the drainage and stabilizing a steep slope threatening a segment of Millers Falls Road, for which the remainder of the project cost will be paid for by a Natural Hazard Mitigation Grant, and the authorize the Board of Selectmen to take any actions necessary to effectuate the purposes of this vote, or to pass any vote or votes in relation thereto.


ARTICLE 3. To see if the Town will vote to raise and appropriate, transfer from available funds or otherwise provide the sum of \$12,000 or any other amount for the purpose of increasing the Fiscal Year 2014 Veterans' Benefits budget, or to pass any vote or votes in relation thereto.


ARTICLE 4. To see if the Town will vote to raise and appropriate, transfer from available funds or otherwise provide the sum of \$8,334 or any other amount for the purpose of providing the Town's share of the cost of repairing existing off Airport (West Mineral Road and Wills Hill) navigation hazard lights, identified as Airport Project AIP 3-25-0032-17, for which the remainder of the project cost will be paid for from a grant from the Federal Aviation Agency and MassDOT, and to authorize the Board of Selectmen to take any actions necessary to effectuate the purposes of this vote, or to pass any vote or votes in relation thereto.




