**ARTICLE 1. MOVED:** That the Town vote to receive the report of the Public Works Facility Planning Committee.      *(Public Works Facility Planning Committee Request)*

**ARTICLE 2. MOVED:** That the Town vote to amend the classification plan adding the position of WPCF Chief Operator at Grade F as per the Memorandum of Agreement between the Town of Montague and the Town of Montague Employees Association dated January 9, 2017.      *(WPCF and Board of Selectmen Request)*

**ARTICLE 3. MOVED:** That the Town vote to amend the classification plan changing the title of WPCF Senior Clerk/Lab Technician to Administrative Assistant/Lab Technician at Grade D as per the Memorandum of Agreement between the Town of Montague and the Town of Montague Employees Association dated January 9, 2017.      *(WPCF and Board of Selectmen Request)*

**ARTICLE 4. MOVED:** That the Town vote to amend the classification plan to modify the duties of the WPCF Operator/Laborer at Grade B as per the Memorandum of Agreement between the Town of Montague and the United Electrical, Radio and Machine Workers of America, Local 274 dated December 20, 2016.      *(WPCF and Board of Selectmen Request)*

**ARTICLE 5. MOVED:** That the Town vote to amend the classification plan to change the title of WPCF Operator to Wastewater Technician at Grade D as per the Memorandum of Agreement between the Town of Montague and the United Electrical, Radio and Machine Workers of America, Local 274 dated December 20, 2016.      *(WPCF and Board of Selectmen Request)*

**ARTICLE 6. MOVED:** That the Town vote to amend the classification plan to add the position of WPCF Lead Mechanic at Grade E as per the Memorandum of Agreement between the Town of Montague and the United Electrical, Radio and Machine Workers of America, Local 274 dated December 20, 2016.      *(WPCF and Board of Selectmen Request)*

**ARTICLE 7. MOVED:** That the Town vote to amend the classification plan to add the position of WPCF Lead Operator at Grade E as per the Memorandum of Agreement between the Town of Montague and the United Electrical, Radio and Machine Workers of America, Local 274 dated December 20, 2016.

**ARTICLE 8. MOVED:** That the town vote to accept the last paragraph of MGL Chapter 41, Section 111F, which allows the town to establish a special injury leave indemnity fund for payment of injury leave compensation or medical bills incurred by a police officer during the performance of his/her duties, appropriate monies into the fund or deposit funds received from insurance proceeds or restitution, and to pay expenses incurred under Section 111F without appropriation with the approval of the Board of Selectmen.

**ARTICLE 9. MOVED:** That the town vote to appropriate sum of \$3,000 for the purpose of increasing the amount appropriated under Article 11 of the May 7, 2016 Annual Town Meeting which appropriation was for the Town's share of Airport Improvement Project 3-25-0032-19 said \$2,500 to be raised from Airport Retained Earnings and \$500 from Free Cash.

MOVED:** That the Town vote to appropriate \$100,000 for the purpose of stabilizing the Strathmore Paper Mill Buildings, including but not limited to the expenditure of funds for roof and sprinkler repair, debris removal, securing the buildings and any other related costs, said sum to be raised from the Town General Stabilization Fund.
