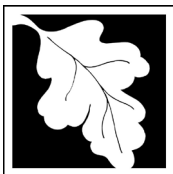
On behalf of Dahna Virgilio, the current property owner, enclosed please find a *Request for Certificate of Compliance* for the above referenced project.
