Director's Report for May 2015

- a) 32 High Street will be in court July 3, 2015. Recently access was denied so there will be an order in the future to gain access to the interior of the house.
- b) 23 Park Street is owned by Pioneer Cooperative there have been ongoing issues working with the Cooperative: they are unresponsive and inept at property management. The COOP is in the process of selling some of their properties; they have 5+/- properties in Turners and others in Greenfield. There was a court case with the 2nd Floor apartment tenants at 23 Park Street which is now vacant and will remain vacant until it is brought up to code.
- c) 10 Sunset Drive in process through the BOH.
- d) Carroll's Market Gina has done some visits to the market and everything appears to be going well regarding the meat counter.
- e) 38 East Main Street this property is being worked on and finally the entry doors to the building are locked and secured with steel plates to prevent jimmying the door locks. The job is moving along.
- f) Gina applied for a \$10,000 grant for climate variability.
- g) Ninth Street (Burned down building) complaints have come in and David is handling through the Building Department.
