Accept Petition regarding handicap accessibility issues

Fairbrother makes the motion to accept the handicap accessibility petition from Sandy Facto. Seconded by Allen, approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother - Aye

Lew Collins, Between the Uprights, Block Party Event

Allen makes the motion that Mark Fairbrother be chair for this item on the agenda. Seconded by Boutwell, approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother – Abstain

Allen: Collins is back before the Board because I asked if he could come back before us because we had some questions regarding the Block Party event and all the signs and hats. There had also been concerns because the event didn't start as an event focusing on children but it is now sort of evolved into that.

Collins: There was a situation last year with someone making a comment over the microphone and that was handled that day and will not happen again. Our mission is not to let anyone up there again.

Allen feels if there are issues again this year, she will have a problem voting for this event again in the future.

Lew looked into signage and the expense is enormous. Over \$8,000 in sign set up, umbrellas are \$250 each. Asked supplier how they would feel if he turned barricades around and they didn't seem to be pleased.

Boutwell returns to meeting and is granted his Chairmanship back.

Bob Trombley, WPCF Superintendent, Continuation of FY13 Sewer Rate discussion from July 2, 2012 meeting Trombley: Last meeting we talked about sewer rates and retained earnings. The state certified amount is \$429,996. Rates have been flat for the last 4 years. I have concerns that sometime in the future, we may not have the retained earnings available at a significant level to affect the rates positively and keep them stable. We have the largest in retained earnings that I can recall. Southworth is interested in the rates remaining flat as I'm sure many of the other industries in town are. It is my suggestion that the Selectboard consider an increase between 3 and 6 percent in the sewer rates for FY 2013. I estimated an increase of 5.2% using \$100,000 of retained earnings. I make this suggestion because should we have a year in which RE are low, the sewer rate increase could run 10 to 20% all in one FY. By allowing small increases over time this can be mitigated. The use of RE must be approved by Town Meeting for which there is no current schedule. Statewide sewer rate figures, calendar year 2010 the last year for which data was available: The statewide 2010 range is \$193 - \$1,455, with an average of \$638 per household. Using the residential rate of \$6.30/1,000 gallons the Montague average household bill based on the state usage figure of 90,000 gallons of usage = \$567; using the actual Montague average flow of 63,260 gallons per residence then the average annual bill becomes \$399 and the increase to the homeowner over FY 2012 is \$19.00 a 5% increase in 2012. There may be some changes as I review my work and discuss with the Town Treasure and Accountant. Retained earnings are funds

certified by the Commonwealth Department of Revenue. The funds concern the Town's enterprise accounting system for the operation of the WPCF, Treasurer's Subsidiary, Highway Subsidiary, Personnel Benefits and Debt Service Budgets. The amount in the fund from a previous fiscal year comes from revenues in excess of those estimated and from unspent appropriations. Use of RE has enabled the Town to mitigate increases in the sewer rates. The agreement between the Southworth Manufacturing Company and the Town (section 4 (e)) notes, "surplus revenues accumulated from Normal Sewer User Fees shall be used to reduce the billing rate of all Normal User Fees in the following fiscal year".

Allen, Boutwell and Fairbrother feel we should not use retained earnings and should keep rate flat

Abbondanzio: This is more than we usually have and I looked at it as a 3 year plan; spend it down in 3 years gradually.

John: Southworth: Feel with retained earnings available should be able to use them. Feels Bob works a good operation and always pulls things together well, our preference would be to have no increase and feel it is in keeping with the agreement that exists between the Town and Southworth

Dave Poirier: Supporting what John said and thinks it makes sound assessment for us to ask that the rates stay the same. Using \$160,000 still leaves quite a bit in emergency funds.

John Hanold: Aware although there have been a lot of process improvements at the plant, the plant is getting older and we have the Erving connections ahead of us. In favor of not dropping rates and not do give backs now in case something happens in the future.

Abbondanzio: Have a meeting with Erving Selectmen on September 17.

Trombley: I miss spoke earlier, we do need to have a public hearing. Use of retained earnings has to be approved by Town Meeting

Fairbrother makes the motion to maintain the previous years rates which would be category I \$5.56/1000; Category III \$6.00/1000; Category III \$334/fiscal year; Category IV \$6.00/1000; Septage – no change: In Town & Town of Gill = \$75/1,000 gallons; Out of Town \$80/1,000 gallons; Other – no change, Interest Rate – 14% per Annum, Demand Charge - \$5.00, Minimum Bill - \$36.00to use the necessary amount of retained earnings to achieve this rate.

Draft Report Sanitary Sewer Pump Station Survey, Paul Gilbert and Craig Wagner, CDM

CDM went through and did a survey of all pump stations and provided a report (which Selectmen were given copies of) This is for information purposes at this time. Location of pump stations are: Poplar Street, G Street, Tech School, First Street, Lake Pleasant, Montague Center, Denton Station and J Street varying ages of stations.

Wagner: Gives out handout which is an overview of the booklet passed out previously. Upgrade stations for reliable sustainable operations for the next 20 years, meet projected capacity needs for the next 20 years; improve overall reliability, including permanent bypass pumping provisions; improve infrastructure security; reduce maintenance and labor; improve monitoring and alarm capability; standardize equipment; comply with applicable codes and standards and eliminate confined space entry. Systems Reviewed: Hydraulic conditions and capacity, pipelines and site considerations, architectural, structural, process mechanical, plumbing, HVAC, electrical, standby power systems, and instrumentation and controls. Key Findings: Capacity limitations, Structural integrity problems, Common Mode Failure; Grandfathered Code Issues, Need for Minor repairs; Confined Space Entry. Recommendations: Replacement with a new precast concrete wet well structure with an integrated valve vault with bypass pumping provisions. Submersible pumps are recommended to address confined space entry. Project Costs: Anticipated planning level project cost for all eight stations ranges from \$6.1 million to \$7.3 million.

Trombley thinks G Street force main pipe might be full of sand and debris, but will be looking into this further. No indication there is a problem other than being dirty and filled up

Susan Mareneck, Director, Montague Catholic Social Ministries, Proposal to include Families Learning Together in the FY2013 CDBG Grant (with Laurie Millman-Center for New Americans)

Mareneck: The reason we are here tonight, I received from you the notice on the 13th that you were going to be talking about the CDBG, but I won't be here. I wanted to come tonight to explain our thinking and our hope about this program. I spoke to Bruce Hunter about this last fall, but we were too late to apply. I explained to him that we were still partnering with the Center for New Americans trying to find funding to do this and many people from this community have been at focus groups and community meetings over the past two years talking about how much they wanted these kind of classes. I explained to him how we were hoping there would be funding in the new contract for the Center for New Americans was going to be applying for this year to make Turners Falls a sight for ESOL classes. Transportation and child care prevented people from getting to the Greenfield sight. This winter the Center for New Americans had an opportunity to apply for some additional funding from the DESE and they decided to try a pilot in Turners Falls

Millman: It was tremendous! Our program has always grown in response to what people need, we don't dictate it, we respond. There was additional money from the state and we said lets see if it fly's, if people come, lets see if we can accommodate people, it was phenomenal.

Mareneck: We were asked to do a census to see if people would be interested and we found over 70 people in Turners Falls that were interested.

Millman: We didn't want to fail in front of the Dept. of Education, they are our primary funder. One of the reasons we are funded so well from them is because our performance record is very good. As much as we wanted to serve the community, we didn't want to risk our reputation, because that is our bread and butter.

Mareneck: It started in February, they did testing and the classes were between 15 and 20 adults. We had a small grant we received from a private foundation and we ran childcare simultaneously for this pilot. It turned out, our theory was right, they had the best attendance at that sight of any of their sights. It really makes a big difference.

Millman: We run the child care not just as child care, but also as early education because the children of parents whose first language is not English also don't have English as their first language and they enter school at a disadvantage. Either we invest in them now and try to get them comfortable in English or we invest in them when they get into the schools.

Mareneck passes out background material

Allen: It sounds like there is an incredible need.

Millman: I think if you look at the cost benefit of helping children before age 3, but certainly pre-school to become literate and fluent in English, the benefits that will accrue to the town from all the rest of the schooling all the way through High School and employability. It's pretty clear, the research is there.

Sally Pick, Solar Update

Pick: We have new t-shirts, lawn signs and brochures. Go to www.solarizemass.com/montague to get all the happenings of what is going on regarding the program. Starting August 7, every other Tuesday from 6:30 – 8:00 PM there will be a representative to answer questions regarding the solar program at the Safety complex. On Wed. Abbondanzio: As you know we just went through a process with civil service and would have used the Regional Assessment Center to select a permanent chief but that didn't; work out when none of the candidates were able to move forward with the Assessment Center, that process ended; what we would have had to do is wait until next year for another written exam. We have an alternative and we're proposing tonight that you go with that alternative and that is to use the Sole Assessment Center and that is a process whereby Civil Service delegates the responsibility to the Town and the Town hires a consultant to do the Assessment Center and that is done in accordance with the delegation agreement. It is a very closely coordinated between the consultant and civil service so they are not totally out of the process but it is a much expedited process, I'm told by the consultant it will be done within two months overall. Tonight, I'm asking that we start that process. Last week I put out a request for quotes, we knew the work would cost less than \$10,000; I talked to the Inspector General's Office to see if there was anyway we could exempt it from Chapter 30B, which is the procurement law, and I was told no. We had to get three quotes. Since it was under \$10,000 we don't have to go out to bid. I got three quotes: Booth Research - \$9,900; MMA Consulting Group - \$7,200 for 5 candidates and \$6,950 for 3 candidates; the low bid was from Badgequest - \$6,600 for 5 candidates. We worked with Badgequest before, we used them in 2004, they are certified with Civil Service and come highly recommended. The money will come out of the Police budget then when we go to Town Meeting we will have to ask for money to restore the funds.

Allen makes the motion to go with Sole Assessment Center process through a delegated agreement and use Badgequest at a cost \$6600 for 5 candidates. Seconded by Fairbrother, approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother – Aye

Detmold asks if Greenfield was approached about joining forces and Abbondanzio stated they are going with a different process that will involve a written test and an assessment center.
