 - O **DPW Construction**. The Carpenters Union has taken all of its people off all jobs throughout the State. The project will likely be backed up for several weeks. Ellis met with the OPM, the architect, and the own of the construction firm to discuss how to amend the flow of work to try to reduce the delay in construction. This may present some budget costs.
 - o **Unity Park Field House.** The roof is complete and we're very happy with the result. Ellis believes the insulation should be relocated, which would fit into the existing appropriation.
 - Strathmore Abatement Project. Our Legal Counsel stands by our assertion that this is an "essential" project., so this project will be proceeding.
 - Complete Streets Construction Project. The bump-outs on Avenue A have been added. Pouring
 concrete for the sidewalks will be done when the weather improves. The work in Montague Center is
 similarly proceeding.
