David Detmold, Tree Advisory Committee

Emerald Ash Borer (EAB) update and action plan

- Detmold states that Emerald Ash Borer has been boring into the ash trees for about a decade.
- This spring the ash trees in Peskeompskut Park are dying.
- We have a chance to intervene to make sure other trees are saved.
- Rafael Vega, an expert on trees, states that the dead trees will need to be taken out of the park.
- Treatment will include injecting the remaining ash trees and monitoring the pest density.
- A one-time injection will be inserted beneath the bark for up to 24 hours. The material will be absorbed by the tree.
- The Tree Advisory Committee voted unanimously to treat the trees.
- The cost for removing the dead trees and treating the remaining trees would require a special appropriation.
- Boutwell makes the motion to endorse the Emerald Ash Borer (EAB) action plan as presented by the Tree Advisory Committee. Boutwell Aye, Lord Aye, Kuklewicz Aye

Presentation of findings and recommendations of the Downtown Turners Falls Parking Study presented by Stantec

Michael Clark from Stantec Consulting gives a PowerPoint presentation: project schedule; study goals; study area; downtown parking inventory; system understanding; downtown parking demand; utilization summary; future demand modeling; public outreach; stakeholder feedback; public survey; findings; designate customer, employee, and resident parking areas; designate spaces for short-term parking and loading; other improvements (wayfinding and multimodal); overnight parking policies; modify overnight winter parking ban; same side street parking; snow emergency alert system; priority corridor designation; introduce regulations to limit long-term vehicle storage on streets; shared parking arrangements; regular utilization counts; special event planning; and public survey - approval of recommendations.

Discussion:

- John Hanold suggests using a snow-emergency-route approach, which prohibits street parking until the snow emergency is lifted.
- FRTA Representative Jeff Singleton thinks downtown parking should be reduced on busy nights due to public transportation's evening service.
- Singleton comments that angle parking is dangerous for bikers.

- Hanold would like the study to include other areas of concentration (i.e., downtown Millers Falls and downtown Montague Center).

Sandy Lane Solar Burn Dump Capping updates and budget review

- GZA has come up with a resolution design to close out the capping of the burn dump. This work is pending approval from DEP.
- It would be up to Kearsarge to implement the design.
- The cost is \$352,032.
- We have an engineering budget of \$247,800; we are projecting a shortfall of \$11,975.

5th and Canal Street Intersection project status review

- The base paving was installed on the 15th.
- Canal Street from Avenue A and Third Street toward the intersection of Avenue A and 7th Street will be milled on August 3rd. That whole area will be repaved.
- Granite curbing will be installed in early August by Roach, the main contractor. The granite may not be available in time for that final pavement. DPW has approved an alternative plan for black asphalt.
- Roach is going to pave over the test pit holes on the river side of the canal, as well as the lower parking lot on 36 Canal Road.
- Roach is willing to do extra sidewalk work from the intersection to 3rd Street and from the intersection to 7th Street.
- Ramsey reviews the budget.
- The Town's \$2.3 million contract with Roach is being reduced to approximately \$804,000. We are projecting there will be about \$1.3 million of grant funding on the table.
- Substantial completion will be done by the end of August.
